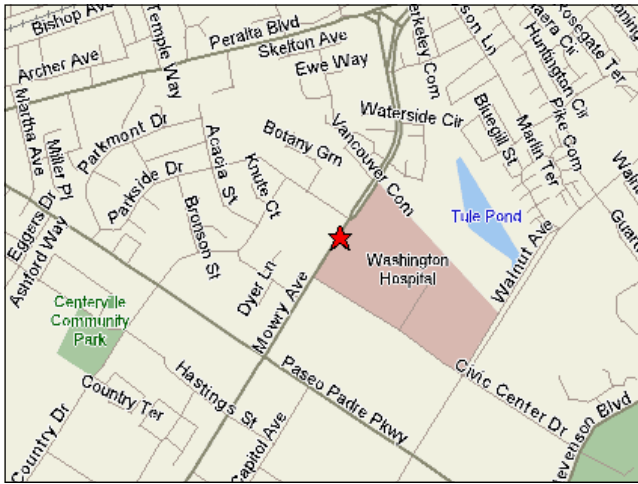

From Milpitas/San Jose: North on Mission Boulevard (238), left on Mowry Avenue (84) or North on 880 to Mowry Avenue East.

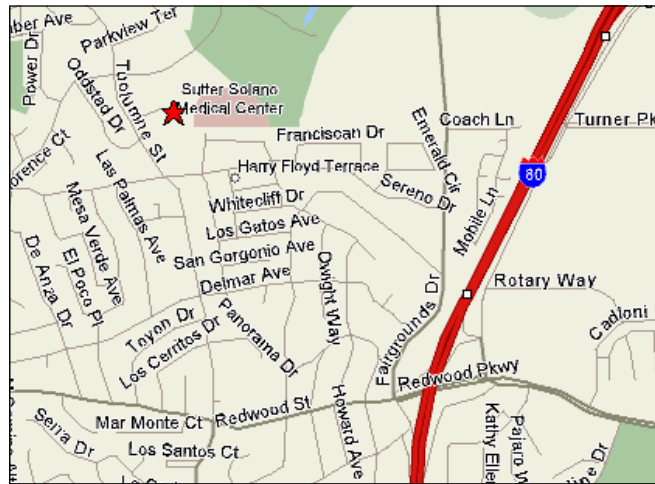
From Pleasanton/Livermore: South on 680 to Mission Boulevard (238) north. Then proceed as above.

From Redwood City/Palo Alto: East on 84, Dumbarton Bridge. South on Paseo Padre Parkway. Left on Mowry Avenue.

From Sacramento: Highway 80 West (San Francisco) Take the Redwood Street off ramp and turn right. Continue on Redwood Road to Tuolumne. Turn right on Tuolumne. Drive up hill to N. Camino Alto. Turn right on North Camino Alto.

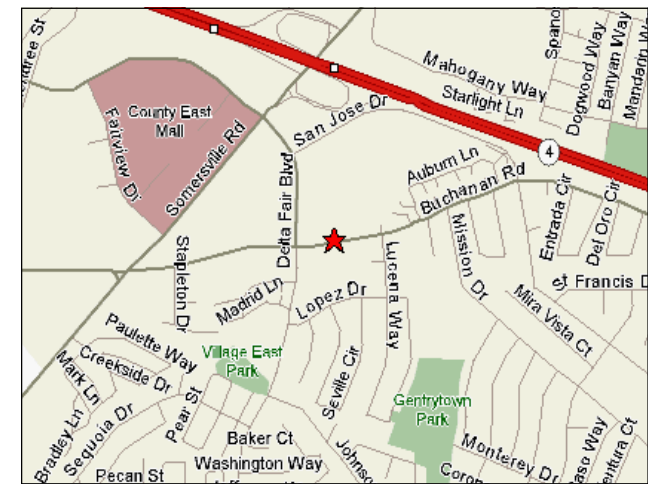
From Concord: Follow 680 North to 780 North. 780 North to Highway 80 East (Sacramento). Take Redwood Road West overpass, going over the freeway. Continue on Redwood Road to Tuolumne and turn right. Drive uphill to N. Camino Alto and turn right.

From Oakland: 80 North towards Vallejo. Take the Redwood Road West overpass, going over the freeway. Continue on Redwood Road to Tuolumne and turn right. Drive uphill to N. Camino Alto and turn right.

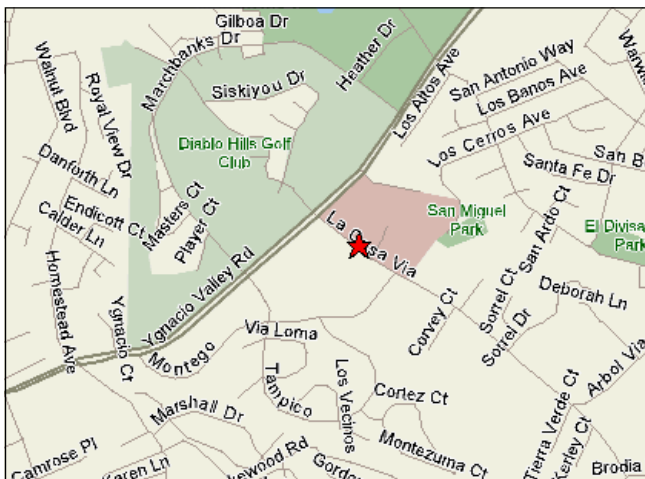


From Tracy/Brentwood: Byron Hwy towards Brentwood Blvd. Take Brentwood Blvd and turn left onto Balfour Road. Turn right onto the Hwy 4 bypass. Left onto Lone Tree Way, left onto James Donlon Blvd, right onto Contra Loma Blvd and left on Buchanan Road.

From Clayton/Walnut Creek: Follow Ygnacio Valley Road until it becomes Kirker Pass Road. Drive into Pittsburg, then go right on Buchanan Road.

From Concord: 680 North and merge onto 242 North. Merge onto Hwy 4 East and exit Somersville Road on go right. Left onto Delta Fair Blvd and left on Buchanan Road.

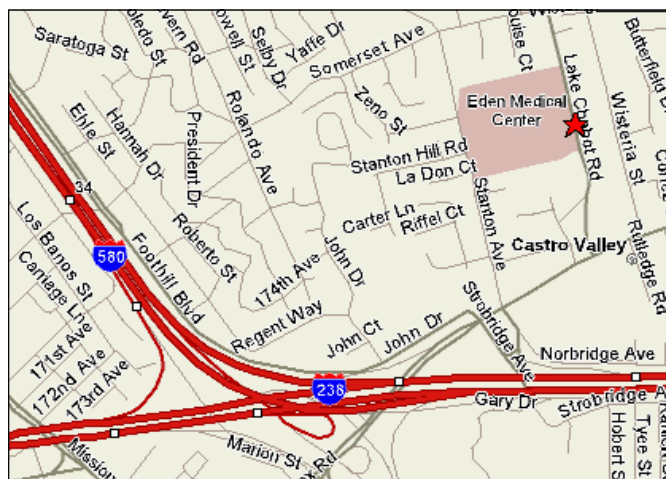
From Concord/Antioch: South on 680 to North Main Street. South to Ygnacio Valley Road, turn left. Right on La Casa Via.

From Pleasanton/Fremont: North 680 to Ygnacio Valley Road. Turn right. Go seven stoplights to La Casa Via, turn right. Go behind 120.

From Richmond/El Cerrito: East on 80 to 4 east, then 680 south to North Main Street. South to Ygnacio, turn left. Right on La Casa Via.

From Oakland: East on 24 / 680 north. First exit right is Ygnacio Valley Road. Turn right, go seven stoplights to La Casa Via. Turn right. We are a half block on the right side, BEHIND 120 La Casa Via.

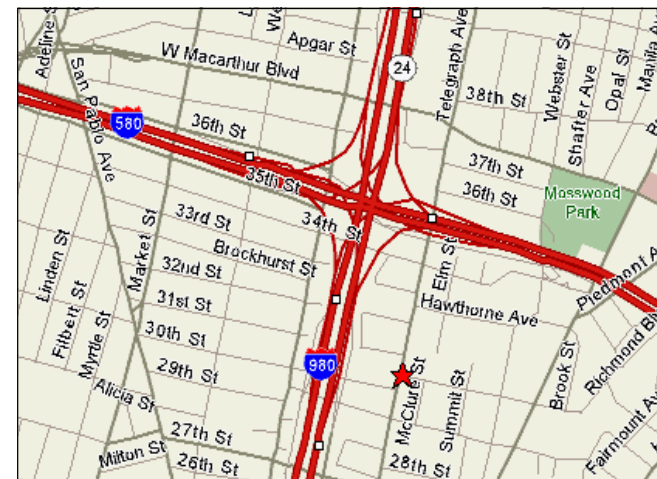


From Fremont/Union City: North on 880, exit onto 238 East (Castro Valley/Stockton/Fresno). Exit Castro Valley Boulevard, turn left under the freeway. Left onto Lake Chabot Road. The entrance to Eden East is on the right, at the first stoplight, across from Eden Medical Center.

From Pleasanton/Livermore: West 580, to Strobridge Avenue, turn right. Right on Castro Valley Boulevard. Left at first stoplight, Lake Chabot Road. Eden East is on the right, across from Eden Medical Center.

From Oakland/Berkeley: East on 580, exit Strobridge Avenue, turn left. Right on Castro Valley Boulevard. First stoplight, go left on Lake Chabot Road. The entrance to Eden East is on the right, at the first stoplight, across from Eden Medical Center.

From Contra Costa County: West on 24, exit West Grand Ave/27th Street. Turn left onto 27th; go to Telegraph Avenue. Turn left. Right on 30th. Metered parking on the street, or at Medical Center Parking Plaza up the hill.

From South Alameda County: From 580 west, exit MacArthur/Harrison. Go straight ahead on MacArthur to Broadway and turn left. Right on 30th. From 880 north, exit Broadway. Turn right on Broadway and go straight about two miles to 30th Street. Turn left on 30th. Park on street or Plaza.

From San Francisco: Take 580 east, exit Broadway/Webster, using the Webster Street branch. At the stop sign turn left and go two blocks to 30th Street, turn right. We are at 30th & Telegraph.
